### MODE OF MEETING

In view of the COVID-19 outbreak and as part of the safety measures, the 50<sup>th</sup> Annual General Meeting (“50<sup>th</sup> AGM”) of Keck Seng (Malaysia) Berhad (“Keck Seng” or the “Company”) will be conducted **FULLY VIRTUAL** via live streaming at the Broadcast Venue. This is in line with the Guidance Note on the Conduct of General Meetings for Listed Issuers issued by the Securities Commission Malaysia on 15 July 2020 (including any amendment that may be made from time to time) (“Guidance Note”).

The Broadcast Venue is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which require the Chairman of the meeting to be present at the main venue of the meeting. Shareholders/proxies/corporate representatives **WILL NOT BE ALLOWED** to attend the 50<sup>th</sup> AGM in person at the Broadcast Venue on the day of the meeting.

### REMOTE PARTICIPATION AND VOTING FACILITIES (“RPV”)

Shareholders will have the option to attend, speak [including posing questions to the Board of Directors (“Board”) via real time submission of typed texts] and vote (collectively, “participate”) remotely at the 50<sup>th</sup> AGM using the RPV provided by Tricor Investor & Issuing House Services Sdn. Bhd. (“Tricor”) via its **TIIH Online** website at <https://tiih.online>.

Shareholders who appoint proxies to participate via RPV in the 50<sup>th</sup> AGM must ensure that the duly executed Proxy Form are deposited in a hard copy form or by electronic means to Tricor no later than **Tuesday, 25 August 2020 at 10.00 a.m.**

Corporate representatives of corporate members must deposit their original or duly certified certificate of appointment of corporate representative to Tricor no later than **Tuesday, 25 August 2020 at 10.00 a.m.** to participate the 50<sup>th</sup> AGM via RPV.

Attorneys appointed by power of attorney are to deposit their power of attorney with Tricor no later than **Tuesday, 25 August 2020 at 10.00 a.m.** to participate the 50<sup>th</sup> AGM via RPV.

**A shareholder who has appointed a proxy to participate at this 50<sup>th</sup> AGM via RPV must request his/her proxy or attorney or authorised representative to register himself/herself for RPV at TIIH Online website at <https://tiih.online>.**

As the 50<sup>th</sup> AGM of Keck Seng is a fully virtual AGM, shareholders who are unable to participate in this 50<sup>th</sup> AGM may appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the Proxy Form.

## PROCEDURES FOR RPV

Shareholders/proxies/corporate representatives/attorneys who wish to participate the 50<sup>th</sup> AGM remotely using the RPV are to follow the requirements and procedures as summarised below:

You will receive an <b>e-mail to notify</b> you that the remote participation is available for registration at TIIH Online.</li> </ul>
(b)	Submit your request	<ul style="list-style-type: none"> <li><b>Registration is open from 10.00 a.m. Wednesday, 29 July 2020 up to 10.00 a.m. Tuesday, 25 August 2020.</b></li> <li>Login with your user ID and password and select the corporate event: “<b>(REGISTRATION) KECK SENG 50TH AGM</b>”.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select “Register for Remote Participation and Voting”.</li> <li>Review your registration and proceed to register.</li> <li>System will send an <b>e-mail to notify</b> that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the General Meeting Record of Depositors as at <b>17 August 2020</b>, the system will send you an <b>e-mail to approve or reject</b> your registration for remote participation.</li> </ul>

(c)	Login to TIIH Online	<ul style="list-style-type: none"> <li>Login with your user ID and password for remote participation at the 50<sup>th</sup> AGM at any time from <b>9.30 a.m.</b> i.e. 30 minutes before the commencement of the 50<sup>th</sup> AGM on <b>Thursday, 27 August 2020 at 10.00 a.m.</b></li> </ul>
(d)	Participate through Live Streaming	<ul style="list-style-type: none"> <li>Select the corporate event: “<b>(LIVE STREAM MEETING) KECK SENG 50TH AGM</b>” to engage in the proceedings of the 50<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will endeavor to respond to questions submitted by remote participants during the 50<sup>th</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> </ul>
(e)	Online Remote Voting	<ul style="list-style-type: none"> <li>Voting session commences <b>from 10.00 a.m. on Thursday, 27 August 2020</b> until a time when the Chairman announces the completion of the voting session of the 50<sup>th</sup> AGM.</li> <li>Select the corporate event: “<b>(REMOTE VOTING) KECK SENG 50TH AGM</b>”.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>
(f)	End of remote participation	<ul style="list-style-type: none"> <li>Upon the announcement by the Chairman on the closure of the 50<sup>th</sup> AGM, the live streaming will end.</li> </ul>

### Note to users of the RPV:

1. Should your application to join the 50<sup>th</sup> AGM be approved, we will make available to you the rights to join the live streamed meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

### GENERAL MEETING RECORD OF DEPOSITORS (“ROD”)

### PROXY

- The 50<sup>th</sup> AGM will be conducted via virtual meeting, if you are unable to attend the meeting via RPV on 27 August 2020, you may appoint the Chairman of the Meeting as proxy and indicate the voting instructions in the Proxy Form.
- You may submit your Proxy Form to Tricor’s Office at Unit 32-01, Level 32, Tower A, Vertical Business Suite, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur, or alternatively, the Customer Service Centre at Unit G-3, Ground Floor, Vertical Podium, Avenue 3, Bangsar South, No. 8, Jalan Kerinchi, 59200 Kuala Lumpur not less than forty-eight (48) hours before the time appointed for holding the 50<sup>th</sup> AGM or any adjournment thereof, otherwise the Proxy Form shall not be treated as valid.

## POLL VOTING

- The Voting at the 50<sup>th</sup> AGM will be conducted by poll in accordance with Paragraph 8.29A of Bursa Malaysia Securities Berhad Main Market Listing Requirements.
- Shareholders can proceed to vote on the resolutions at any time from the commencement of the 50<sup>th</sup> AGM at 10.00 a.m. until the end of the voting session which will be announced by the Chairman of the Meeting. Kindly refer to item (e) of the above Procedures for RPV for guidance on how to vote remotely from **TIIH Online** website at <https://tiih.online>.
- Upon completion of the voting session for the 50<sup>th</sup> AGM, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
